FILMING CONDITIONS & REQUIREMENTS

HOLLYWOOD RESERVOIR PROPERTY

1. Discretion must be exercised for filming activity in the proximity of potable reservoir water. On a case-by-case basis, Los Angeles Department of Water and Power (LADWP) will make the final determination for the allowable distances that must be maintained from the reservoir water.
2. Rain storms in early 2005 created extensive landslide activity on the north east and North West portion of the reservoir property and subsequent closure of patrol roads. Ingress/egress to the reservoir property will **only** be allowed through the Weidlake Drive gate at the south eastern portion of the property.
3. Limited areas of the patrol roads on the south east and south west of the property may be used for filming activity. The lower reservoir dam roadway may also be used for filming activity.
4. LADWP security shall be stationed along these roadways during the filming activities to assure that no filming personnel travel to a designated unsafe landslide area.
5. Appropriate clearance from chlorine facilities shall be maintained. Film crews shall keep a minimum distance of fifty (50) yards from the structure or as far away as the nearest property perimeter fence. Patrol roads, which are adjacent to chlorine facilities, will be used for ingress/egress through the property, not for filming activity. In the case of Hollywood Reservoir, Lake Hollywood Drive, which is the nearest roadway as well as a public street, meets this requirement.
6. No filming has historically been allowed, nor will it be allowed, on, in, over, or immediately adjacent to any unprotected potable water supply.

FILM PERMIT

1. All proposed film locations must be on the permit or no filming will be allowed. Scenes shall not identify the Hollywood Reservoir or DWP insignia/seals.
2. Any changes that that are requested after the filming permit has been issued must be approved by the filming coordinator.
3. If wiring is on the ground, pedestrian crossovers must be used.

FILM PERMIT COMPANY

1. All proposed film locations must be on the permit or no filming will be allowed.
2. If wiring is on the ground, pedestrian crossovers must be used.
3. The production company will be responsible for the conduct of all cast and crewmembers. All cast and crewmembers will honor off limit areas.
4. Production companies must clean all areas that they occupied.

DEPARTMENT WIDE POLICIES AND PROCEDURES

A Primary Filming Monitor will be the person that all film crews communicate with. If there is a need for any provisions or you have any questions during your filming project at the facility, see this film monitor. LADWP personnel are not to be disturbed.

- There will be a LADWP monitor(s) on duty at every film or photo shoot (number of monitors will be determined on the Technical Scout).
- Security will remove any member of the cast or crew who becomes verbally or physically abusive.
- No alcoholic beverages will be allowed on LADWP property (NO EXCEPTIONS).
- No smoking is permitted on LADWP property (except designated areas).
- No weapons are allowed on LADWP property (guns, knives, etc.)
