BOSS pays you incentives for energy savings achieved through the installation and implementation of a variety of energy efficiency measures and equipment that meet or exceed minimum industry standards.

Eligible Measures Include:

High efficiency cooling equipment, variable speed drives, CO monitoring systems, industrial process upgrades, and RCx measures, among many others.

Switch your existing gas equipment to all electric and receive electrification incentives too!

Requirements

- Participant must be a LADWP commercial customer in good standing.
- All equipment and/or measures must meet or exceed applicable California Energy Code minimum efficiency requirements and/or industry standards.
- All projects must undergo pre-installation verification and receive pre-approval prior to installation and/or implementation.

Domestic Hot Water	\$0.15	\$0.15
Domestic Hot Water (All electric)	\$0.65	\$0.65
Building Envelope	\$0.25	\$0.25
Whole Building ³	\$0.25	n/a

*Any End Use categories indicating negative energy efficiency savings and incentives will be deducted from the project's total efficiency savings and incentive amount. This does not pertain to building electrification measures.

¹Applications for lighting measures will be accepted only when submitted in conjunction with another non-lighting BOSS-qualified measure. The BOSS-qualified measure must achieve a minimum of 100,000 kWh in energy savings. Both the BOSS-qualified and lighting measure must be applied for and completed simultaneously. Failure to complete the BOSS-qualified measure will render the lighting measure ineligible for payment. Refer to the Commercial Lighting Incentive Program for specific details about lighting incentive rates and requirements.

²Includes associated retro-commissioning (RCx)/controls and building envelope measures

³Inclusive of all building end uses combined, IPMVP Option C only.
