ELIGIBILITY

- To be eligible for incentives under this Program, project must be a non-residential or multi-family high rise new construction or renovation/remodel project located within LADWP's service territory.
- The Proposed Design must exceed Title 24 or current industry standards for energy efficiency by at least five percent (5%) to qualify.
- Estimated energy savings and incentives calculated from those savings will be based on energy efficiency improvements beyond the minimum current Title 24 requirements and/or industry standards.
- To be eligible for incentives under this Program, Applicant agrees that they will not apply for or receive any other incentive offered by local, state or federal entities or utilities for measures or services covered under this Agreement without prior approval from LADWP.

TERMS

- I have read, understand, and agree to comply with all terms, conditions, and requirements of the LADWP Zero By Design program. I understand that I am responsible for the accuracy of all project documentation submitted to LADWP.
- I understand that LADWP will reject application packages if any of the information provided is inaccurate.
- I understand by applying for an LADWP incentive and/or program, personal information provided may be subject to public disclosure by requesting parties, pursuant to the California Public Records Act.
- I am in compliance with my state/county/city governments' requirements regarding local conditions, restrictions, codes, ordinances, rules, or regulations. I have obtained all required permits and will provide them to LADWP upon request.
- I certify that the information I have provided is true and correct and the project for which I am requesting an incentive payment meets the requirements of the LADWP Zero By Design new construction incentive program.
- The Measure must exceed Title 24 Standards.
- Measures may not be applied for nor may Applicant receive incentives from multiple LADWP energy efficiency programs for the same measure. Only one (1) incentive will be paid per energy efficiency or electrification measure.
- LED Horticultural Lighting products must be listed on the DesignLights Consortium's (DLC) Qualified Products List (QPL) - <https://qpl.designlights.org> - to qualify. Equipment must meet or exceed all applicable DLC Horticultural Lighting Technical Requirements in effect at the time of application. In addition to being DLC listed, all proposed products must have a Power Factor (PF) greater than or equal to 0.9 and total harmonic distortion (THD) less than or equal to 20% to qualify. Please note, DLC qualified products may not be tested at numbers that do not meet the threshold required by the LADWP for PF and THD. Products not meeting the minimum requirements for PF and THD will not be eligible for LADWP incentives despite DLC listing. Please make certain the products you have selected meet LADWP's PF and THD requirements prior to applying. Customers must submit documentation to validate their proposed products meet the program requirements listed above.
