

## Non-Profit Community Partnership Outreach Grants Program APPLICATION FORM

## Eligible organizations must:

- A. Have maintained 501(c)3 non-profit status for the past three years and be located in the City of Los Angeles; this can be shown through IRS registration and/or a publicly accessible regular workspace in the City of Los Angeles.
- B. Have established track record of providing services to the community especially relating to education, energy, water or economic-related issues.
- C. Demonstrate a commitment toward encouraging sustainability through its current and/or future programs and structure.
- D. Have the capacity to track numbers of constituents reached, engaged and referred, sustainability benefits achieved, and maintain financial and labor records acceptable for a City audit.
- E. Propose activities at least 50% focused on energy efficiency versus water conservation. Retrofits for organizations' own facilities will not be funded; however, public-serving retrofits and/or demonstrations may comprise up to 1/3 of the proposed budget. Research activities must inform education/outreach activities and be limited to 1/3 of the proposed budget.
