CHAPTER 6: COORDINATION AND CONSULTATION

6.1 INTRODUCTION

This chapter presents the City of Los Angeles Department of Water and Power's (LADWP) public and agency involvement and outreach activities, satisfying the California Environmental Quality Act (CEQA) requirements for public scoping and agency consultation and coordination for the Sylmar Ground Return System (SGRS) Replacement Project (Project). CEQA Guidelines Section 15129 states that an "EIR [Environmental Impact Report] shall identify all federal, state, or local agencies, other organizations, and private individuals consulted in preparing the draft EIR." LADWP is the Lead Agency under CEQA for the proposed Project.

Consistent with CEQA, public participation and agency consultation for this Project have been accomplished through issuance of public notices, public scoping meetings, and formal and informal consultation with agencies, stakeholders, landowners, and Native American tribes. The consultation and coordination process helped to determine the scope of the Draft EIR and identify a range of alternatives and mitigation measures.

6.2 SCOPING PROCESS

Scoping is the process for determining the scope of issues to be addressed in the Draft EIR. The public, affected agencies, Native American tribes, and other interested parties are invited to participate in the environmental review process. The following sections summarize the scoping process.

6.2.1 Notice of Preparation

In compliance with CEQA Guidelines Section 15082, a Notice of Preparation (NOP) of an EIR was prepared that described the proposed Project and location, environmental review process, potential environmental effects, and contact information. The NOP was published in the Los Angeles Times on September 23, 2010. On September 24, 2010, the NOP (State Clearinghouse [SCH] No. 2010091044) was filed with the SCH; the scoping review period started on September 24, 2010 and ended on October 25, 2010. A copy of the NOP was distributed via certified U.S. mail to:

- 50 agencies (city, county, State, and federal)
- 5 elected officials
- 5 community organizations
- 6 businesses
- 9 libraries
- 15 schools

Please refer to Section 6.4 for a summary of Native American scoping comments, including those comments received in response to issuance of the NOP.

6.2.2 Scoping and Public Meetings

A scoping meeting was hosted by LADWP during the scoping review period on October 14, 2010, at the LADWP headquarters building in Los Angeles. Invitations were mailed in advance to jurisdictional agencies and agencies believed to have an interest in the Project; no invitees attended this meeting.

Additional public meetings were conducted on the dates and locations listed in Table 6-1. The purpose of the meetings was to inform the public about the Project; describe its purpose and need; provide

information regarding the environmental review process; and gather public input regarding the content of the Draft EIR.

Aesthetics and Visual Resources

The Temescal Canyon Association, California Department of Parks and Recreation, Pacific Palisades Community Council, Topanga Canyon Docents, and the Santa Monica Mountains Conservancy all commented on the Topanga State Park Alignment and the visual impacts this particular alignment would cause to the park. The Brentwood Community Council also strongly supported the undergrounding of as many of the replacement lines as possible to reduce aesthetic impacts. The Brentwood Homeowners Association also strongly supports the undergrounding of all existing overhead wires leading to the Kenter Canyon Terminal Tower.

Air Quality

The South Coast Air Quality Management District (SCAQMD) recommended the identification of potentially adverse air quality impacts from all phases of the Project, as well as the preparation of a mobile health risk assessment. SCAQMD also stated that any significant adverse air quality impacts would require implementation of all feasible mitigation measures.

In addition, numerous members of the public were concerned about the air pollution the Project construction would generate in the Brentwood area.

Alternatives

Several Brentwood residents expressed support for the Topanga State Park Alignment over the San Vicente Alignment to avoid environmental impacts in the Brentwood area. The Los Angeles Unified School District (LAUSD), along with several other residents, wanted an alternative option that would remove the above ground electrical transmission lines that exist along the west side of Kenter Elementary School; LAUSD suggested undergrounding the portion of the above ground line that runs along the elementary school. In contrast, the Santa Monica Mountains Conservancy opposed the Topanga State Park Alignment in favor of the San Vicente Alignment. The Pacific Palisades Community Council, Topanga Canyon Docents, Santa Monica Mountains Conservancy, and the Temescal Canyon Association also opposed the proposed Topanga State Park Alignment. The Brentwood Homeowners Association stated that any action to tear up Kenter Avenue should be automatically rejected. The California Department of Fish and Wildlife requested that a range of alternatives be analyzed to ensure that alternatives to the proposed Project are fully considered and evaluated.

Biological Resources

The California Department of Fish and Wildlife commented that a complete assessment of flora and fauna within and adjacent to the Project area would be required, with particular emphasis upon identifying endangered, threatened, and locally unique species and sensitive habitats; direct, indirect, and cumulative impacts expected to adversely affect biological resources; an examination of potential mitigation measures; and required permits.

Cultural Resources

According to the Native American Heritage Commission (NAHC), cultural resources were identified within one-half mile of the Topanga State Park Alignment. Consultation with tribes and interested Native American tribes was strongly encouraged as required by law.

Fire

Some residents commented on the potential fire hazard for residents in the Kenter Canyon area.

Hazards

The Brentwood Community Council expressed concern with the potential significant health impacts of the overhead electric lines; they requested that concerns of safety be fully studied in the Draft EIR. LAUSD commented that there could be larger electromagnetic field strengths from new aboveground power lines located adjacent to Kenter Elementary School because the new lines would be of larger diameter and carry a larger amount of electricity; as such, they requested the preparation of an analysis of EMF exposures to Kenter Elementary School students and staff related to existing power lines and proposed upgrade to determine if EMF exposure would increase or decrease.

Land Use

The California State Lands Commission commented that they should be consulted in regards to construction activities and permitting requirements.

Noise

Brentwood residents expressed concern regarding the level of noise that would be generated by the proposed Project over the construction period.

Recreation

A Los Angeles City Councilman from the 12th District suggested providing an off-street bicycle path along the main overhead alignment, beginning in Sylmar and ending at Mulholland Drive.

Transportation and Traffic

Several Brentwood residents expressed concerns regarding Project-related traffic impacts that would result from road closures and trench digging along heavily traveled routes such as Sunset Boulevard, Pacific Coast Highway, San Vicente Boulevard, Kenter Avenue, and the nearby intersection of Interstate 405. The California Department of Transportation (Caltrans) recommended that LADWP provide a construction management plan and a cooperative agreement; Project coordination with Caltrans and the California Highway Patrol; and the limitation of construction truck trips to off-peak hours. The Metropolitan Transportation Authority requires a Traffic Impact Analysis and an analysis of development-related impacts to transit.

Water Resources

The California Department of Fish and Wildlife expressed concern related to effects on watercourses, or canalization or conversion of natural or human-made drainages. Also, the U.S. Army Corps of Engineers commented that a permit for the discharge of dredged or fill material in waters or wetlands of the U.S. may be required, pursuant to the Clean Water Act.

6.4 FORMAL CONSULTATION

6.4.1 Native American Coordination

The NAHC was contacted on two occasions to perform a Sacred Lands File search in the NAHC Sacred Lands File Inventory, established by the Legislature pursuant to Public Resources Code 5097.94(a). Responses with tribal contact lists were received on September 7, 2009, and July 8, 2010. A third list was received from the NAHC on September 20, 2010, in its response to the CEQA NOP. The NAHC recommended using consulting parties from the tribes that may have knowledge of the religious and cultural significance of the historic properties in the Project area (e.g., areas of potential effect). A Native American tribe or Tribal Elder may be the only source of information about a cultural resource. Also, the NAHC recommended that a Native American Monitor or Native American culturally knowledgeable person be employed whenever a professional archaeologist is employed during the Initial Study and in other phases of the environmental planning processes.

6.5 PUBLIC REVIEW OF DRAFT EIR

6.5.1 Notice of Completion

Per CEQA Guidelines Section 15085, the Notice of Completion is a document that must be filed with the SCH, Office of Planning and Research, when the Draft EIR is published. The CEQA Lead Agency shall also provide the public a Notice of Availability (NOA) of the Draft EIR (CEQA Guidelines Section 15087). The NOA will also include details for any scheduled public meetings or hearings (date, time, and place); a list of significant environmental effects; and whether the Project site is listed under Section 65962.5 of the Government Code (hazardous waste facilities). Pursuant to CEQA Guidelines Section 15105, the public review period for a Draft EIR submitted to the SCH shall be no less than 45 days nor should it be longer than 60 days except under unusual circumstances.

6.5.2 Public Review

In accordance with CEQA requirements, this Draft EIR will be circulated for public and agency review and comment for a 45-day period.
