

**NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION
FOR THE PROPOSED NORTH HOLLYWOOD CENTRAL GROUNDWATER TREATMENT ACTION**

Subject: Notice of Intent to Adopt a Mitigated Negative Declaration for the Proposed North Hollywood Central Groundwater Treatment Action

An Initial Study/Mitigated Negative Declaration (IS/MND) has been prepared by the City of Los Angeles Department of Water and Power (LADWP) for the proposed North Hollywood Central Groundwater Treatment Project. LADWP is the Lead Agency, pursuant to the California Environmental Quality Act (CEQA), responsible for preparation of this document.

PROJECT DESCRIPTION

The Los Angeles Department of Water and Power (LADWP) proposes to implement a response action to address a regional plume of certain hazardous substances in groundwater that has migrated and continues to migrate to the Rinaldi-Toluca (RT) Well Field. LADWP has curtailed the use of several groundwater production wells in the RT Well Field due to the presence and/or threat of 1,4-dioxane and volatile organic compounds, collectively termed herein as contaminants of concern (COCs), contamination at the wells. Under current conditions, the beneficial uses of groundwater in the vicinity of the RT Well Field will continue to be impaired, and other LADWP wells may be affected in the future by the continued spread of these contaminants.

The proposed response action would be achieved by installing water treatment equipment capable of removing the COCs to below identified cleanup levels at the North Hollywood Pump Station property. The response action would protect human health and the environment by reducing the potential for exposure to COCs at unhealthy concentrations in groundwater, limit the migration of COCs from groundwater in the vicinity of the RT Well Field, remove COCs from the groundwater in the vicinity of the RT Well Field, assist in the restoration of beneficial uses of the groundwater basin, and restore LADWP's capability to operate its existing RT Well Field in a flexible manner consistent with historic and planned use.

PROJECT LOCATION

The treatment equipment would be located on property owned by LADWP within the North Hollywood Pump Station Complex, which is located north of Vanowen Street, between Hinds and Morella Avenues, in the North Hollywood Community of Los Angeles. The affected groundwater extraction wellheads are located within the LADWP public utility easement along Whitnall Highway. Pursuant to Section 15072 of the California Environmental Quality Act, the Project site is not on any of the lists enumerated under Section 65962.5 of the Government Code.

PUBLIC COMMENT PERIOD
