AN INITIAL STUDY/MITIGATED NEGATIVE DECLARATION

FOR THE PROPOSED AD HOC YELLOW-BILLED CUCKOO HABITAT

ENHANCEMENT PLAN

The City of Los Angeles Department of Water and Power (LADWP) is proposing to implement the Ad Hoc Yellow-billed Cuckoo Habitat Enhancement Plan at Baker and Hogback Creeks, located in Inyo County, California. As the Lead Agency under the California Environmental Quality Act (CEQA), the LADWP has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) which evaluates the potential environmental effects of the proposed project.

Project Location

The proposed enhancement projects are located at two sites within Inyo County, the Baker Creek site and the Hogback Creek site. The 1,411-acre Baker Creek habitat area is located along Baker Creek and Giroux Ditch approximately 1.5 miles west of Big Pine. The 111-acre Hogback Creek habitat area is located at the northwest corner of the Alabama Hills, west of U.S. Highway 395 and between the towns of Independence and Lone Pine.

Project Description

LADWP proposes to implement the Ad Hoc Yellow-billed Cuckoo (YBC) Habitat Enhancement Plan at Baker and Hogback Creeks. The goal of implementing the Ad Hoc Yellow-billed Cuckoo Habitat Enhancement Plan is to maintain and/or improve habitat conditions at Baker and Hogback Creeks to potentially increase the population of YBC in California. The proposal provides for the planting and establishment of riparian vegetation; grazing practices that are compatible with riparian vegetation; continued recreational use of the sites with safeguards for resource protection; and, a suite of monitoring and adaptive management protocols to guide the enhancement plans over the life of the project.
